Speech by GOH Mr Eric Chua

Guest-of-Honour and Parliamentary Secretary Mr Eric Chua gave the opening speech at the workshop. Here are excerpts of his speech:

- Financial planning is important for us to plan for ourselves to make sure we have enough to retire on and to live decently in our old age.
- For caregivers of persons with special needs (PSNs), they want to ensure their financial needs and caregiving are taken care of when they are no longer around.
- This topic came up very strongly during discussions with caregivers of PSNs on what they wish to see in the next Enabling Masterplan¹.
- Financial planning for the caregivers of PSNs may seem overwhelming and some may not even know where to start.
- To better support caregivers in this area, MSF set up SNTC in 2008 to provide affordable and riskfree trust services for PSNs, and to help caregivers plan for the long-term financial and caregiving needs of their loved ones, among other goals.
