### Have You Done Your LPA Form 1?

The application fee for LPA Form 1 is waived for Singapore citizens until <u>31 March 2023</u>. After which, the application fee returns to \$75.

To get Form 1 done in a timely manner, get your donees to fill in their particulars before you meet a certificate issuer (CI) to complete the application.

# LPA Form 2

Form 2 allows you to customise the powers that you give to your donees.

For example, you may want your PWD to respect your vegan diet or you may want your PAD to not sell a certain property first when cashflow is tight. Keon will share case studies of families and SME owners who set up Form 2.

## **Professional Doneeship**

The Professional Deputies and Donees (PDD) scheme was set up to serve individuals, especially elderly singles or childless elderly couples, who may not have family members or close friends to rely on to be their proxy decision makers.

Professionals registered under this scheme include lawyers, doctors, accountants, nurses, social workers and trust companies.

Seow Ling will share the main reasons that people use the PDD and some case studies.

## Advance Care Planning (ACP)

ACP can be described as the software of your estate plan. The ACP allows you to provide your why's and values behind your decisions in your Will, Trust, LPA and other documents.

It helps you to plan for your future health and personal care. It includes discussing one's personal beliefs and goals for care with their loved ones and healthcare providers.
